OUR TERMS & CONDITIONS

DEPOSIT

YOUR CAKE ORDER WILL ONLY COMMENCE ONCE A DEPOSIT HAS BEEN PAID.

THE DEPOSIT MUST BE PAID AS SOON AS POSSIBLE TO SECURE THE AGREED COLLECTION DATE.

FINAL PAYMENT MUST BE MADE AT LEAST 2 WEEKS BEFORE DELIVERY OR PICK-UP.

THE DEPOSIT IS NON-REFUNDABLE.

CAKE ALTERATIONS

CANCELLATION POLICY
